

## Visitor Code of Conduct

- 1. On arrival you must:
  - Sign-in at reception located at the front of the site
  - Read and understand the 'Visitor Code of Conduct' (this document)
  - Sign a declaration to the effect that you understand your obligations particularly with regard to safety
  - Wear the appropriate visitor's pass (given to you on completion of the induction process)
- 2. A designated car park is provided for visitors, please park accordingly
- 3. Volgren is a drug, alcohol and smoke-free workplace
- 4. Visitors must be correctly attired, this means:
  - Appropriate footwear (leather, closed and not high-heeled)
  - Safety glasses (factory areas only)
  - High visibility 'Visitor' vest
  - Shorts are <u>not permitted</u> in the (indoor and outdoor) Production
     Areas (factory areas only)
  - Hearing protection (factory areas only)
- 5. All visitors must declare any **Dangerous Goods** and/or **Hazardous Substances** prior to bringing them onto the Volgren premises
- 6. Mobile phone usage is not permitted in production or traffic areas
- 7. **No photographic or digital recording is permitted on site**. Requests for Volgren approved images can be submitted to a Management Representative. You will be met by your host at reception and escorted at all times
- 8. On departure, you must proceed to reception to **sign-out** and return the visitor pass and safety equipment (high-viz vest and safety glasses)
- 9. In the event of an evacuation your host will guide you to the Assembly Area. Please follow instructions of your host, Volgren's Fire Wardens & / or emergency services.
